IQS Mid year review

The IQS Mid year review provided formative feedback on the progress towards meeting target benchmarks on the ScoreCard.

There are 5 categories in the report: Mission/Program Model, Governance, School Performance, Finance, School Operations.

The report mentions opportunities for improvement for each category which have been fixed since the school received the report last February.

The overall comment of the report is very positive.

Employee manual 2024-2025 changes

During the last meeting, board members talked about some changes regarding J1 teacher in the employee manual. The purpose was to add a clause to the employee manual to help retaining the teachers: in case the teacher leaves before the end of the 3 year visa, the teacher will have to reimburse the administrative fees.

Discussion was postponed until the school co-coordinators gather info from the sponsor Amity.

Amity confirmed that the reimbursement of the administrative fees can be part of the onboard process. The school will have to write it on the Local Fees, Cost Summary, and School Information Form provided by Amity

No need to change the employee manual

Results of teacher vote and IQS approval for change in bylaws

Section 2. Board Composition Structure. The Board shall consist of not fewer than five (5) nor more than (11) unrelated members. — A majority of the Board shall at all times consist of licensed teachers employed by Notre Ecole School or providing instruction under contract with the Corporation. A majority of the Board shall at all times consist of members of the community.

100% of the teachers voted for the change in the board structure. The majority of the board members should be now community members instead of teachers.

Vote on updated FY 25 budget

Jean-Christophe Ricaud presents the updated FY 25 budget

Cash position:

- -Strong cash generated by the school in 23/24 higher than BP and last year
- -Includes \$40,000 of reimbursement of the Note payable from 22/23
- -Expect to end the year higher than BP (contingent timing of funds payments)

Budget:

- -Budget is low right now budget as it was based on 60 students (Currently school has 55 students)
- -Received \$68k in gift& donation (\$50k planned in the BP)
- -Revenue and expenses lower than BP due to Special education (2 students in the BP did not return to the school)
- -Should break even at the end of the school year

Budget 2024/2025:

- -Budget is conservative
- -APU can change depending on the state.
- -Revenue only includes \$20,000 of Gift & donation, lower than usual.
- -Library & student support aid of \$20,000 each included.
- -Expenses increase mainly related to 1 new teacher, 1 office staff & increase in costs
- -Cost per student of \$12,196 in line with other BP
